STUDENT SUSPENSIONS/EXPULSIONS

Suspensions

The District Administrator, building principal or teacher designated by the principal may suspend a student from school for the period of time authorized by law for any of the following reasons:

1. noncompliance with Board policies.
2. noncompliance with rules made by the District Administrator, principal or teacher designated by the principal with consent of the Board.
3. knowingly conveying any threat or false information concerning an attempt or a alleged attempt being made, or to be made, to destroy any school property by means of explosives.
4. conduct while at school or under the supervision of a school authority which endangers the health, safety or property of others.
5. conduct while not at school or while not under the supervision of a school authority which endangers the health, safety or property of others at school or under the supervision of a school authority, or of any District employee or Board member of the District.

In addition, a student shall be suspended from school when required by law (e.g., possessing a firearm in violation of state law).

All student suspensions shall be reasonably justified and shall be administered in accordance with state law and established procedures.

Expulsions

Students may be recommended to the Board for expulsion from school if they have engaged in any of the following type of conduct:

1. repeated refusal or neglect to obey Board policies, District rules or school rules.
2. knowingly conveying any threat or false information concerning an attempt or alleged attempt being made, or to be made, to destroy any school property by means of explosives.
3. conduct while at school or under the supervision of a school authority which endangered the property, health or safety of others.
4. conduct while not at school or while not under the supervision of a school authority which endangered the health, safety or property of others at school or under the supervision of a school authority, or of any District employee or Board member.
5. repeated conduct while at school or while under the supervision of a school authority that disrupted the ability of school authorities to maintain order or an educational atmosphere at school or at an activity supervised by a school authority and such conduct does not constitute grounds for expulsion under any of the other reasons for expulsion outline above.

The Board may expel a student from school whenever it finds that the student engaged in any of the above conduct and is satisfied that the interest of the school demands the student's expulsion.

A student shall be expelled from school for engaging in conduct outlined in state law which requires the student's expulsion (e.g., possessing a firearm in violation of law).

Expulsions of all students, including students with disabilities, shall be in accordance with state and federal laws, and established district policies and procedures.

The Board may specify conditions in a student's expulsion order that would allow the student to be reinstated to school early before the end of the term of the expulsion. The early reinstatement condition(s) shall be related to the reason(s) for the expulsion and shall be enforced in accordance with state legal requirements.
