**EMERGENCY NURSING SERVICES**

Emergency nursing services may be provided in the Dodgeland School District in accordance with state laws and regulations. The objective of the nursing services is the maintenance of the physical, mental and emotional health of students while they are at school or participating in school activities. Emergency nursing services may be available during the school day and during school curricular and co-curricular activities.

In providing for emergency nursing services, the district shall:

1. Arrange for a nurse currently registered in Wisconsin to direct the emergency nursing services program. The nurse will be knowledgeable and have skills in emergency nursing care.
2. Establish emergency nursing policies and procedures under the direction of the registered nurse in cooperation with other school district personnel and representatives from community health agencies and services as may be designated by the Board. These policies and procedures will be approved by the medical advisor and adopted by the Board
3. Have protocols in place for dealing with accidental injury and illness, administering medication and the recording of accidents/incidents and services performed. Such protocols shall include procedures to be used at all school-sponsored activities.
4. Arrange for a medical professional to serve as medical advisor for the emergency nursing services program. The medical advisor will review the policies and procedures and advise the district regarding health services. A formal request/agreement shall be prepared annually that states the name of the medical professional who will serve as the District's Medical Advisor.
5. Designate individual's in each school and for all school functions to be responsible for implementing emergency care procedures.
6. Maintain first aid equipment and supplies in the school office of each building to provide emergency care in accordance with established procedures.
7. Maintain a record system which includes accident investigation reports and a log of services rendered.
8. Ensure that emergency information cards are on file for all students in the District.
9. Annually review the emergency nursing services program in accordance with established procedures.
